PROVISION OF TRANSPORT SERVICES FOR REN CI CLIENTS

Ren Ci Community Hospital (RCCH) provides rehabilitative care to post-acute patients from restructured hospitals (CH), long term care services for patients with multiple chronic illness and poor functional ability (CSU), as well as Senior Care Centre (SCC) services serving day care and day rehabilitation clients. It has a maximum capacity of 241 patient beds and 70 clients in the SCC

Ren Ci @ Ang Mo Kio (Nursing Home) (AMKNH) provides day care, rehabilitation, and residential care services to lower income clients/ residents. It has a maximum capacity of 472 residential beds and 120 clients in the SCC

Ren Ci @ Bukit Batok St.52 (Nursing Home) (BBNH) provides Residential Care (NH) and Senior Care Centre (SCC) services to lower income clients/ residents. It has a maximum capacity of 256 residential beds and 80 clients in the SCC

Ren Ci @ Woodlands (WNH) is our third Nursing Home. It will provide day care, rehabilitation, and residential care services. WNH will have a maximum capacity of 332 residential beds, 120 clients in the SCC and 88 staff dormitory beds.

We are looking for vendors to provide transport services for our wheelchair bound and ambulant clients and their caregivers to the various Ren Ci Centres at the following location.
